To implement this policy, the OHS policy implication (TH-HSEC-OHS-MA-01) is developed. In accordance with the policy implication, we periodically conduct OHS policy and OHS Management System and Culture Integration review comprising of OHS Management System, OHS Competency and OHS Awareness and Behavior to ensure suitability, adequacy, effectiveness and continuous improvement. The measurable indicators will be established after reviewing policy. Quality Assurance Review (QAR) system is also applied to monitor and review performance in order to ensure that this policy's goals and targets would be achieved. HSEC-Corporate would conduct QAR with country in every operations at least once in every two years.
