### 5. BANPU Definition of Independent Director

Banpu Public Company Limited has defined the definition of Independent Directors which is equal to those defined by Securities and Exchange Commission and the Stock Exchange of Thailand. "Independent Director" of the Company means the director who possesses the following qualifications:

- 1. A person holding no more than 5 per cent of paid-up capital of the Company, its subsidiaries, affiliates or relevant companies; this shall include shares held by relating persons.
- 2. A non-executive director in the management of the Company, its subsidiaries, affiliates, relevant companies or major shareholders; a person who is not an employee or consultant regularly. receiving monthly salary from the Company, its subsidiaries, affiliates, relevant companies or major shareholders
- 3. A director with no direct or indirect benefit or interest in financial or in management aspects of the Company, its subsidiaries, affiliates, relevant companies or major shareholders including the person not having benefit or interest in such a manner one year prior to his appointment unless the Board of Directors has thoroughly considered that such interest or benefit in the past will not affect his performance and opinion as an independent director
- 4. A director who is neither related to nor be a closed relative of the Company's executives or major shareholders
- 5. A director not appointed as a representative to maintain the interests of the Company's directors or major shareholders or shareholders relating to the Company's major shareholders
- 6. A person who is able to perform duties, express opinions or report results of performances based on his duties entrusted by the Board of Directors independently without subject to any control of the Company's executives or its major shareholders including those relating thereto or closed relatives thereof
