Subject: Notification regarding the End of the General Offer Period in respect of Shares of Banpu Power Public Company Limited and the Purchase of Shares by way of a Trade Report (Big Lot)

To: President of the Stock Exchange of Thailand

Reference: Notification to the Stock Exchange of Thailand No. 0168/068 dated 18 November 2025

We, Banpu Public Company Limited (the “**Company**”), refer to the general offer by us to acquire all the remaining shares of Banpu Power Public Company Limited (“**BPP**”) from other shareholders of BPP (the “**Offer**”) during the period from 1 to 23 December 2025, totaling 15 business days, the details of which are as disclosed to the Stock Exchange of Thailand on 18 November 2025. Accordingly, we would like to inform that the general offer period has now come to an end.

In this regard, Kiatnakin Phatra Securities Public Company Limited which acts as the Company’s offer agent for this general offer (the “**Offer Agent**”), will proceed to execute the acquisition of BPP shares from the shareholders of BPP who have accepted the Offer pursuant to the general offer, in an aggregate amount of 378,460,106 shares, representing approximately 12.42 percent of the total issued and outstanding shares of BPP, by way of a trade report (Big Lot) on 24 December 2025, and will subsequently deliver BPP shares (as deposited by the offerees with the Offer Agent) and those which have been converted from NVDR (as transferred to the Offer Agent) to the Company by 26 December 2025 or within 3 business days after the end of the offer period. The offerees will receive the payment of the share purchase price within 4 business days from the end of the offer period, i.e. within 29 December 2025, provided that the acceptance form and other supporting documents required and submitted by the offerees in respect of the shares intended to be sold by them in the general offer are correct and complete, and those shares intended to be sold have been duly delivered to the Company.

Please be informed accordingly and disseminate the information herein to investors.
