We, Banpu Public Company Limited (the “**Company**”), refer to our previous disclosure to the Stock Exchange of Thailand (“**SET**”) on 30 October 2025 regarding Resolutions of the Board of Directors' Meeting in connection with the Internal Group Restructuring whereby the Board of Directors' Meeting has resolved to approve the entry into the general offer to acquire shares in Banpu Power Public Company Limited (“**BPP**”) from other shareholders of BPP in the total remaining amount of 650,532,203 shares, representing approximately 21.34 per cent of the total issued and outstanding shares of BPP prior to the amalgamation between the Company and BPP.

In this regard, the Company wishes to inform that it intends to commence the general offer during 1 to 23 December 2025 for a total period of 15 business days. The offer price has been set at Baht 13.00 per share, which remains unchanged from the offer price indicated in our previous disclosure to the SET. The Company has submitted a copy of the General Offer dated 18 November 2025 (the “**Offer Document**”), attached hereto, to BPP on the date hereof for information and disclosure to the shareholders of BPP. The printed copies of the Offer Documents will be distributed (via Thailand Securities Depository Co., Ltd.) to the shareholders of BPP, whose names appear in BPP's share register book as of 10 November 2025.

Please be informed accordingly and disseminate the information herein to investors.

To Shareholders of Banpu Power Public Company Limited

We, Banpu Public Company Limited (the “**Offeror**”), hereby offer to purchase the shares in Banpu Power Public Company Limited (the “**Business**”) for 650,532,203 shares, representing approximately 21.34 percent of the total issued and outstanding ordinary shares in the Business, thereby increasing the Offeror’s aggregate shareholding in the Business from approximately 78.66 percent of the total issued and outstanding ordinary shares to 100.00 percent of the total issued and outstanding ordinary shares in the Business, in the event that all shareholders accept the offer, in accordance with the following terms and conditions (the “**General Offer**”):

The General Offer does not constitute a tender offer under Section 247 of the Securities and Exchange Act B.E. 2535 (1992) (as amended) and is not subject to any regulatory requirements or conditions applicable to tender offers, including those specified under the Notification of the Capital Market Supervisory Board No. TorJor. 12/2554 entitled Rules, Conditions and Procedures for the Acquisition of Securities for Business Takeovers (as amended). Shareholders should exercise their own judgment and consult with professional advisors before making any decision in connection with the General Offer. It should also be noted that the Office of the Securities and Exchange Commission has neither reviewed nor approved the terms and conditions of the General Offer.

**Part 1****Key Terms of the General Offer****1. Date of Submission of the Offer Document**

**2. Name of the Offeror**

Banpu Public Company Limited

**3. Name of the Offeror**

Kiatnakin Phatra Securities Public Company Limited (the “**Offer Preparer**” and “**Offer Agent**”)

**4. Objectives of the General Offer**

The Offeror’s objective of the General Offer is to increase the Offeror’s shareholding in the Business as an investment, as the Offeror has confidence in the Business’s growth potential and expects to receive favourable investment returns.

**5. Type and Amount of the Shares Intended to Purchase**

As at the date of the submission of the Offer Document, the Business has only one type of shares which is an ordinary share. The Business has the total outstanding ordinary shares of 3,047,731,700 ordinary shares at the par value of Baht 10.00 per share, whereby 1 ordinary share is entitled to 1 voting right.

As at the date of submission of the Offer Document, the Offeror holds a total of 2,397,199,497 ordinary shares in the Business, representing approximately 78.66 percent of the total issued and outstanding ordinary shares and total voting rights of the Business.

In the General Offer, the Offeror intends to acquire 650,532,203 ordinary shares in the Business, representing approximately 21.34 percent of the total issued and outstanding ordinary shares and total voting rights in the Business. If all shareholders accept the General Offer, the Offeror will hold a total of 3,047,731,700 ordinary shares in the Business, representing approximately 100.00 percent of the total issued and outstanding ordinary shares in the Business.

**6. Offer Price**

The offer price for the Business’s shares is Baht 13.00 per share (Baht Thirteen) (the “**Offer Price**”). The shareholders who accept the General Offer (each an “**Offeree**”) are subject to a brokerage fee of 0.25 percent of the Offer Price and value added tax of 7.00 percent of the brokerage fee. Therefore, subject to any applicable withholding taxes as described in the below paragraphs and Part 4 of this Offer Document, the net price to be received by the Offeree will be equivalent to Baht 12.965225 (Baht Twelve Point Nine Six Five Two Two Five) per share.

In the calculation of the payment for each Offeree, the Offer Agent will take the Offer Price multiplied by the number of shares intended to be sold, and round any fraction of the payment to 2 decimal places, and a numeral in the third decimal place that is less than 5 will be rounded down, but the numeral that is equal to 5 or greater will be rounded up.

*For Foreign Juristic Persons*

Pursuant to the Revenue Code of Thailand (unless specifically exempted under the terms of an applicable double tax treaty), in case that the Offeree is a foreign juristic person not operating any business in Thailand and not residing in a country which has a double tax treaty with Thailand, or residing in a country which has a double tax treaty with Thailand but such double tax treaty does not exempt such foreign juristic person from withholding tax on capital gains realized from the sale of securities in Thailand, such Offeree is subject to a deduction of 15.00 percent withholding tax on the capital gains from the sale of shares, i.e., the difference between the Offer Price and the original cost which the Offeree has paid for the shares intended to be sold. The Offeree must declare the original cost of the shares intended to be sold to the Offer Agent by submitting the form in Attachment 1 Form A-4 for the ordinary shares and Attachment 2 Form B-4 for Non-Voting Depository Receipts (“**NVDR**”).

In the event that any Offeree fails to declare such original cost together with the Form for Confirmation of Cost of Shares Intended to be Sold to the Offer Agent, the Offer Agent will deduct the withholding tax which will be calculated on the basis of the Offer Price multiplied by the total number of shares of the Business or of NVDRs intended to be sold by the Offeree.

*For Thai Juristic Persons*

An Offeree, which is a Thai juristic person, will be responsible to withhold 3.00 percent tax on the brokerage fee and shall issue a withholding tax certificate to the Offer Agent.

*For Individual Persons (Thai Residents and Non-Thai Residents)*

Under the Revenue Code of Thailand, capital gains derived by individual shareholders from the sale of shares on the SET are exempted from personal income tax and are not required to be included in taxable income. In respect of the General Offer, the Offer Agent intends to execute the share acquisition through the trade report (Big Lot) method in accordance with the rules and procedures prescribed by the SET. Based on the Offeror’s understanding, transactions conducted through the trade report (Big Lot) is deemed a sale on the SET. Accordingly, any capital gains realized by individual shareholders from such sales would be exempted from personal income tax. Individual shareholders are advised to consult with their own professional tax advisors regarding any tax implications of participating in the General Offer.

However, if the trade report (Big Lot) transaction cannot be executed due to the SET's requirements, the transaction may be carried out off-market, in which case the Offerees, who are individuals, would be subject to personal income tax on capital gains. Please refer to the details of the purchase procedures in Clause 2 of Part 4 of the General Offer and please note that non-Thai residents may also be subject to the tax laws applicable in their country of residence.

## 7. Offer Period

The Offeror will purchase the shares for a total period of 15 business days, commencing from 1 December 2025 to 23 December 2025 (inclusive of the first and last day) (the “**Offer Period**”), during the office hours of the Offer Agent, from 9:00 a.m. to 4:00 p.m. (Bangkok time).

If the share certificates are rejected by the Thailand Securities Depository Co., Ltd (“**TSD**”) for deposit, the Offeror and/or the Offer Agent reserve the right to reject the General Offer Acceptance Form submitted by the Offeree and the Offer Agent will notify the Offeree to collect the share certificate. In the case that the Offeree submits the General Offer Acceptance Form within 22 December 2025 and 23 December 2025 (which are the last 2 business days of the Offer Period), the Offer Agent reserves the right to reject the General Offer Acceptance Form submitted by the Offeree and the Offer Agent will notify the Offeree to collect the share certificate.
- (2) In Case of Shares Deposited with TSD (Scripless): The Offeree must contact the securities company, with which the Offeree has the brokerage account and deposit the shares and submit 1 set of the duly signed documents mentioned in Clause 1.2.3 of Part 4 to transfer scripless shares intended to be sold into the account of the Offer Agent.
- (3) In case of shares deposited with TSD, under the issuer account no. 600: the Offeree must complete and sign, accurately and clearly, and submit the form “Securities Transfer to / from Issuer Account with Participant” (“**TSD-403**”) enclosed in Attachment 1 Form A-6, together with 1 set of identification documents of securities holder, according to the type of person indicating in page 2 of TSD-403, in addition to the General Offer Acceptance Form with 1 set of supporting documents as stated under in Clause 1.2.3 in Part 4 in order to transfer scripless shares intended to be sold into the account of the Offer Agent. The Offeree shall submit the

General Offer Acceptance Form and the supporting documents within 19 December 2025 or at least 2 business days prior to the last day of the Offer Period to provide sufficient time to verify and process the shares transfer. If TSD-403 is rejected by TSD, the Offeror and/or the Offer Agent reserve the right to reject the General Offer Acceptance Form submitted by the Offeree. In the case that the Offeree submits the documents on 22 December 2025 and 23 December 2025 (which are the last 2 business days of the Offer Period), the Offer Agent reserves the right to reject the General Offer Acceptance Form submitted by the Offeree if the transfer cannot be completed within the Offer Period or TSD-403 is rejected from TSD.

For an NVDR, there will be a process of converting an NVDR into scripless ordinary share and the Offer Agent cannot accept the NVDR if the NVDR is not converted into scripless ordinary share within the Offer Period. Thus, in order that the Offeree can sell the shares within the Offer Period, the Offeree should submit the General Offer Acceptance Form and 1 set of its supporting documents as stated in Clause 1.2.3 in Part 4 within 19 December 2025 or at least 2 business days prior to the last day of the Offer Period to provide sufficient time for conversion of an NVDR into scripless ordinary share. **12. Payment Date**

The Offeror will make a payment to each of the Offerees in respect of the shares intended to be sold by each of them in the General Offer within 4 business days from the last day of the Offer Period, which is by 29 December 2025, provided that Acceptance Forms including supporting documents submitted by the Offerees in respect of the shares intended to be sold by them in the General Offer must be correct and complete, and the shares intended to be sold by the Offeree have been successfully transferred to the Offeror.

**13. Sources of Funds to Finance the General Offer**

The source of funds for the General Offer will be from the Offeror's internal cash and borrowings. The Offeror intends to acquire 650,532,203 ordinary shares, representing approximately 21.34 percent of the total issued shares of the Business at the Offer Price of Baht 13.00 per share. In the event that all shareholders accept the General Offer, the total maximum funds required for the Offeror for the General Offer will amount to approximately Baht 8,456.92 million.

According to the Offeror's reviewed financial statements for the nine-month period ended on 30 September 2025, the Offeror has total cash and cash equivalents of Baht 47,093.15 million and shareholders' equity of Baht 159,146.61 million, respectively which indicates that the Offeror has sufficient funds to purchase 650,532,203 ordinary shares in the Business under the General Offer amounting to approximately Baht 8,456.92 million.

### 3. Settlement and Payment Procedures

#### 3.1. Payment Date
